ORDINANCE NO. 08-02

AN ORDINANCE AMENDING PREVIOUS ORDINANCES ASSESSING FEES FOR FIRE PROTECTION BUREAU FUNCTIONS WITH RESPECT TO CONSTRUCTION WITHIN THE BOUNDARIES OF THE WARRENVILLE FIRE PROTECTION DISTRICT

WHEREAS, the Warrenville Fire Protection District (the "District") is a fire protection district duly incorporated under the laws of the State of Illinois (70 ILCS 705/1 et seq.); and

WHEREAS, the District has established, adopted and continues to maintain a fire prevention code for the benefit and safety of both residents and non-residents of the District parallel to national standards in accordance with 70 ILCS 705/11; and

whereas, it has been and remains the intention of the District to require that all structures and buildings erected and constructed within the boundaries of the District are built and constructed in accordance with the terms of District's fire prevention code, as well as the laws of the State of Illinois relating to building construction; and

WHEREAS, a necessary and essential action to ensure compliance with the District's fire prevention code and State building related laws requires District review of all structure and building plans, blueprints and other construction documents for both building and life safety purposes; and

WHEREAS, such review by the District of structure and building plans, blueprints and other construction documents requires considerable time and expertise by appropriately training officers of the District; and

WHEREAS, in recognition of these recitations, on January 9, 1995, the Board of Trustees of the Warrenville Fire Protection District adopted its Ordinance 95-1 entitled "AN ORDINANCE PROVIDING FOR NEW CONSTRUCTION, ALTERATIONS, SUPPRESSION SYSTEMS AND AUTOMATIC ALARM SYSTEM APPROVAL FEES WITHIN THE WARRENVILLE FIRE PROTECTION DISTRICT," a copy of which is

attached hereto and identified as **Exhibit A**, and which by this reference in hereby incorporated within these recitations; and

WHEREAS, on March 20, 1997, the Board adopted an amendment to Ordinance 95-1 by the adoption of Ordinance 97-01; and

WHEREAS, the Board hereby finds that there is a need to again amend its Ordinances to change the fee structure for certain inspections and tests that have become more expensive to the District over the past eleven years.

NOW, THEREFORE, BE IT ORDAINED by the Board of Trustees of the Warrenville Fire Protection District, DuPage County, Illinois, as follows:

<u>Section One:</u> That the Board hereby finds that all of the recitals contained in the preambles to this Ordinance are full, true and correct and they are incorporated into this Ordinance by reference.

Section Two: Effective October 15, 2008, the plan review and other fees charged by the District's fire prevention bureau are increased in accordance with the fee schedule attached to this Ordinance as Exhibit B.

Section Three: All such fees shall be due and payable upon submission of the structure and building plans, blueprints and other construction documents submitted for review; and no review or approval shall be rendered by District personnel until all such fees have been paid-in-full.

Section Four:

All revenue generated from the fees and charges assessed pursuant to this Ordinance shall be deposited in the corporate fund of the Warrenville Fire Protection District.

Section Five: All parts of Ordinance 95-1 and Ordinance 97-1 that are in conflict or inconsistent with the provisions of this Ordinance are hereby repealed to the extent that they may conflict.

Section Six: The invalidation of any section, part, provision, term or phrase of this Ordinance by a court of competent jurisdiction shall not affect the validity of the remaining sections, parts, provisions, terms or phrases of this Ordinance.

<u>Section Seven:</u> This Ordinance shall be in full force and effect from and after its passage and approval.
