

ORDINANCE NO. 13-01

**AN ORDINANCE AMENDING ORDINANCE 08-02 WHICH ORDINANCE
AMENDED FEES ASSESSED FOR FIRE PREVENTION BUREAU
FUNCTIONS WITH RESPECT TO CONSTRUCTION WITHIN THE BOUNDARIES
OF THE WARRENVILLE FIRE PROTECTION DISTRICT, DuPAGE COUNTY, ILLINOIS**

WHEREAS, the Warrenville Fire Protection District (the "District"), DuPage County, Illinois, is a fire protection district duly incorporated under the laws of the State of Illinois, including the Illinois Fire Protection District Act (the "Act", 70 ILCS 705/0.01 et seq.); and

WHEREAS, the Board of Trustees of the District (the "Board") has full power pursuant to Section 6 of the Act (70 ILCS 705/6), to pass all necessary ordinances, and rules and regulations for the proper management and conduct of the business of the Board for carrying into effect the objects for which the District was formed; and

WHEREAS, Section 11 of the Act (70 ILCS 705/11) empowers and makes it the legal duty and obligation of the District's Board to provide as nearly adequate protection from fire for all persons and property within the District as possible and to prescribe necessary regulations for the prevention and control of fire therein; and

WHEREAS, the District's Board has express power pursuant to Section 11 of the Act (70 ILCS 705/11) to adopt and enforce fire prevention codes and standards parallel to national standards to promote fire prevention; and

WHEREAS, the District is empowered by the Act to provide reasonable safeguards through Fire Prevention Codes to protect the Public Health and Safety against the hazards of fire in buildings and structures; and

WHEREAS, pursuant to said authority the Board adopted Ordinance 08-02 on October 13, 2008 entitled "AN ORDINANCE AMENDING PREVIOUS ORDINANCES ASSESSING FEES FOR FIRE PREVENTION BUREAU FUNCTIONS WITH RESPECT TO CONSTRUCTION WITHIN THE BOUNDARIES OF THE WARRENVILLE FIRE PROTECTION DISTRICT" ("Ord. 08-02"), which Ord. 08-02 amended plan review and other fees in a superseding Exhibit B

incorporated as part of Ord. 08-02 charged by the District's Fire Prevention Bureau pursuant to Ordinances 95-1 adopted by the Board on January 9, 1995, and Ordinance 97-1 adopted on March 20, 1997; and

WHEREAS, the Board finds there is a need and that it is in the best interest of the District and its residents to again update and amend the fee structure for certain plan reviews, and facility inspections and equipment tests that have become more expensive to the District.

NOW, THEREFORE, Be It Ordained, by the Board of Trustees of the Warrenville Protection District, DuPage County, Illinois, as follows:

Section One: The Board finds and determines the above recitals to be true and correct, and incorporates them as if written out here in full.

Section Two: The plan review and other fees charged by the District's Fire Prevention Bureau, identified in Ord. 08-02's Exhibit B of are repealed in their entirety and replaced with the plan review, facility inspection and equipment test fees identified in **Exhibit B** attached to this amendatory Ordinance, and by this reference incorporated herein.

Section Three: Pursuant to authority of the Illinois law including but not limited to the Fire Protection District Act, the Board may from time-to-time amend the fees charges for plan review, facility inspection and equipment test fees identified in **Exhibit B** attached to this amendatory Ordinance for services rendered by the Warrenville Fire Protection District Fire Prevention Bureau, identified in this Ordinance by duly and properly adopting any such amendatory and superseding Exhibit B at a meeting convened pursuant to the Open Meetings Act, memorializing the amendatory Exhibit B, the effective date of the amendatory Exhibit B, and recording in the minutes of said meeting the roll call vote of the Board approving said amendment.

Section Four: Nothing in this Ordinance, Ord. 08-02, Ordinance 97-01 or Ordinance 95-1 shall preclude the assessment of fees or other charges pursuant to any other District ordinance or resolution.

Section Five: The Board ratifies, reaffirms and readopts all un-amended provisions of Ordinance 08-02, Ordinance 97-01 and Ordinance 95-1.

Section Six: The Fire Chief is hereby authorized to waive any or all of the fees due under Ordinance 95-1, Ordinance 97-01, and this amendatory Ordinance. He may do so by policy or on an individual basis.

Section Seven: Any person or entity that refuses to pay or fails to pay the above-listed service charges within sixty (60) days of notice of the charge will be deemed to have violated this Ordinance. The District reserves the right to pursue all remedies at law and equity to recover charges due and owing, including the use of the services of a collection agency.

Section Eight: The provisions and sections of this Ordinance shall be deemed severable and the invalidity of any portion of this Ordinance shall not affect the validity of the remainder.

Section Nine: That this Ordinance shall be in full force and effect from and after its passage and approval.
