

**GENERAL ORDINANCE NO. 95-1A
WARRENVILLE FIRE PROTECTION DISTRICT
DUPAGE COUNTY, ILLINOIS**

**ORDINANCE FOR RULES AND REGULATIONS OF THE
WARRENVILLE FIRE PROTECTION DISTRICT**

WHEREAS, the Trustees of the Warrenville Fire Protection District on the 5th day of May, 1989, adopted Rules and Regulations of the Board of Fire Commissioners of the Warrenville Fire Protection District, State of Illinois, and which said Rules govern the appointment and removal of full-time paid officers and members of the Warrenville Fire Protection District; and

WHEREAS, the Rules of the Board of Fire Commissioners heretofore referred to herein do not govern the appointment and removal of paid-on-call or volunteer officers or members of the Warrenville Fire Protection District; and

WHEREAS, the aforementioned Rules of the Board of Fire Commissioners make it incumbent upon all full-time paid members and officers of the Warrenville Fire Protection District to comply with all other Ordinances of the District governing the performance of the duties of all officers and members of the District; and

WHEREAS, it is desirable to avoid conflict in the ordinances of the District; and

WHEREAS, it is necessary to differentiate between those rules pertaining to full-time paid employees and part-time employees where appropriate.

NOW THEREFORE, BE IT ORDAINED by the Board of Trustees of the Warrenville Fire Protection District as follows:

SECTION I: The following rules and regulations shall govern the employment of all members of the Warrenville Fire Protection District and shall be followed by all officers and members of the District in the performance and execution of their duties to said department. Unless the provisions of these rules so specify, these rules shall govern full-time paid employees, paid-on-call and volunteer officers and members of the Warrenville Fire Protection District. Where these rules are in conflict with the Rules and Regulations of the Board of Fire Commissioners of the Warrenville Fire Protection District adopted on the 13th day of February, 1995 and as revised on the 13th day of February, 1995 the provisions of said rules of the Board of Fire Commissioners shall take precedence and control.

To the extent that the provisions of applicable law, the Rules and Regulations of the Board of Fire Commissioners of the Warrenville Fire Protection District adopted on February 13, 1995 and revised on February 13, 1995 this General Ordinance, other Ordinances of the Warrenville Fire Protection District or any of the Rules and Regulations of the Warrenville Fire Protection District are in conflict, applicable law controls followed by this General Ordinance, the other Ordinances of the Warrenville Fire Protection District and the Rules and Regulations of the Warrenville Fire Protection District, in that order.
