

ORDINANCE 96 - /

AN ORDINANCE AMENDING ORDINANCE NO. 93-2

WHEREAS, the Trustees of the Warrenville Fire Protection District on the 10th day of may, 1993, adopted Ordinance No. 93-2; and

WHEREAS, Ordinance No. 93-2 references rules and provisions contained in the BOCA NATIONAL FIRE PREVENTION CODE published by Building Official and Code Administrators International, Inc., 1990 edition, and the LIFE SAFETY CODE (NFPA NO. 101), published by the National Fire Protection Association, the 1991 edition; and

WHEREAS, said BOCA NATIONAL FIRE PREVENTION CODE and said LIFE SAFETY CODE has been amended since the date of the passage and adoption of Ordinance No. 93-2; and

WHEREAS, the CABO ONE AND TWO FAMILY DWELLING CODE, has been issued and is used by the Warrenville Fire Protection District since the date of adoption of Ordinance 93-2; and

WHEREAS, the Board of Trustees of the Warrenville Fire Protection District find it necessary to amend Ordinance No. 93-2 to reflect the amendments to the BOCA NATIONAL FIRE PREVENTION CODE and the LIFE SAFETY CODE and to incorporate the CABO ONE AND TWO FAMILY DWELLING CODE.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE WARRENVILLE FIRE PROTECTION DISTRICT AS FOLLOWS:

1. All references in Ordinance 93-2 to the BOCA NATIONAL FIRE PREVENTION CODE published by Building Official and Code Administrators International, Inc., 1990 edition and the LIFE SAFETY CODE (NFPA NO. 101), published by the National Fire Protection Association, the 1991 edition shall include all amendments and supplements to said codes.

2. All rules and provisions contained in the CABO ONE AND TWO FAMILY DWELLING CODE are incorporated into Ordinance No. 93-2 and herein by reference thereto as fully as if set out in it's entirety herein and in Ordinance No. 93-2 and said CABO ONE AND TWO FAMILY DWELLING CODE is hereby adopted by the Warrenville Fire Protection District.

3. The BOCA NATIONAL FIRE PREVENTION CODE, LIFE SAFETY CODE and CABO ONE AND TWO FAMILY DWELLING CODE together with amendments thereto and additions set forth in Ordinance 93-2 shall be known as the Warrenville Fire Protection District Board's Fire Prevention Code.

This ordinance shall become and be effective immediately upon its passage, approval, and publication in a manner prescribed by law.
