ORDINANCE AMENDING WARRENVILLE FIRE PROTECTION DISTRICT ORDINANCE NO. 95-1

WHEREAS, the Trustees of the Warrenville Fire Protection District on the 9th day of January, 1995, adopted Ordinance No. 95-1 entitled, "An Ordinance Providing for New Construction, Alterations, Suppression Systems and Automatic Alarm System Approval Fees within the Warrenville Fire Protection District"; and

WHEREAS, Ordinance No. 95-1 provides in Section 3, entitled Application Fees, subpart entitled, "Automatic Alarm Systems" sets forth plan approval fees on increasing scale based upon square footage thresholds; and

WHEREAS, the Warrenville Fire Protection District has incurred increased man power costs created by submission of plans for approval for larger buildings than anticipated at the time of the enactment of Ordinance 95-1; and

WHEREAS, 70 ILCS 705/1, provides that Fire Protection Districts are created in the public interest to promote and protect the health, safety and welfare and convenience of the public and to therefore engage in the establishment, maintenance and operation of facilities for the prevention and control of fires and the establishment of regulations with respect thereto; and

WHEREAS, 70 ILCS, 705/6 provides that the Board of Trustees of a Fire Protection District is to carry into effect the purposes of which the District is formed; and

WHEREAS, 70 ILCS/11, provides that the Board of Trustees of a Fire Protection District is obligated to prescribe necessary regulations for the prevention and control of fires and may adopt and enforce protection codes and standards parallel to national standards; and

WHEREAS, the Warrenville Fire Protection District is charged with the responsibility of reviewing, analyzing and approving plans and specifications for new and existing construction of all property within the District; and

WHEREAS, the Board of Trustees of the Warrenville Fire Protection District has determined that it is in the public interest that the costs of this process should be born by the property owner and/or building permit applicant seeking the review, analysis and approval of the new and existing construction codes and ordinances of the District.

NOW, THEREFORE, be it ordained by the Board of Trustees of the Warrenville Fire Protection District, DuPage, Illinois as follows:

Section 1.

Section 3 of Ordinance No. 95-1 entitled, "Application Fees" shall be amended by this Ordinance to revoke and rescind the following:

<u>Automatic Alarm Systems</u> - Automatic fire alarm systems covering pull stations and detection in buildings under 10,000 sq. ft. shall pay a fee of \$35.00 for plan approval and an additional \$35.00 for acceptance test.

Systems over 10,000 sq. ft. shall pay a fee of \$70.00 for plan approval and an additional \$35.00 for acceptance test.

Section 2.

The foregoing provisions shall be revoked and rescinded and replaced with the following:

- 1. New construction or alteration fees for up to and including three stories as defined in BOCA National Building Code, Chapter #5 and Fire District Ordinance shall be due and payable in amounts as set forth on Exhibit "A" attached hereto and made a part hereof as though fully set forth herein.
- 2. New High Rise Construction fees for four stories or more in height as defined in BOCA National Building Code, Chapter #5 and Fire District Ordinance shall be due and payable in amounts as set forth on Exhibit "B" attached hereto and made a part hereof as though fully set forth herein.

This Ordinance shall become and be effective immediately upon its passage, approval and publication prescribed by law.
