CHIEF'S REPORT

Chief Dina presented the Chief's report for September and October 2022.

Chief Dina reported for the months of September/October 2022, the District responded to 313 calls for service, and that the District is on track for 1866 calls for the year.

Chief Dina reported that there have been recent events in which the District has provided an ambulance with medics on stand-by, and that is a new stream of revenue.

Chief Dina mentioned the District is working on recruitment and retention, and has recently updated the policies for cadets, part-timers, and paid-on-call requirements respectively. Chief would like to initiate a new program that would refresh the current cadet program, which he will present to the Trustees at this month's meeting.

The District's Family Christmas Party will be held on December 4th at the Station.
